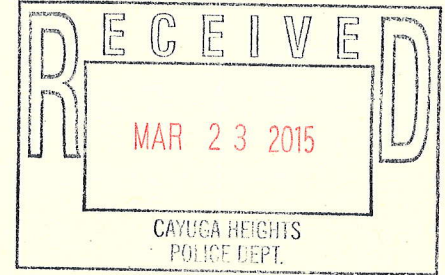

If for any reason any portion of my request is denied, please inform me of the reasons for the denial, fully, in writing and provide the name and address of the person or body to whom an appeal should be directed.
